DVD development. ONE Freedom is developing a script and concept of a DVD by applying the ONE Freedom training model and neurophysiology underpinnings on stress and trauma to a veteran audience. When completed, this project will create a 20-30 minute multi-media film of the ONE Freedom message geared toward returning veterans in higher education.

4b (Code:) (Expenses \$ 23,772. including grants of \$) (Revenue \$)

Website development and Launch. ONE Freedom in conjunction with Foraker Design developed a web platform that provides a powerful platform for educating military and public audiences regarding services, resources, and programming. Current programs can be run from anywhere in the country and participants can sign up on line for current programming. The website also has a database and information collection portal as well as the ability to handle donations and donor development.

4c (Code:) (Expenses \$ 17,955. including grants of \$) (Revenue \$ 7,542.)

Education & training. Deliver education on the basics of neurophysiology including the key areas of the brain and autonomic nervous system, and training on skills that teach individuals how to self-regulate the stress response. The primary programs "Strength in Service" and "Strength after Service" relate the stress response to combat experiences, service during war time, and families and civilians dealing with a war time deployment cycle. Each training collects pre- and post-training surveys for data collection and metrics. Data and results are used to refine trainings.
